Stop Blackwater Rally

-- Rep. Bob Filner Speaks

Our "Stop Blackwater" Encampment, rally, and march to the gates of the proposed Blackwater West facility was a rousing success, despite a variety of roadblocks that were coincidentally timed with the event. Fortunately, the news of Blackwater's September 16th shooting in Iraq, killing 17 people, hit just a few weeks prior to event, and the testimony of Erik Prince, the founder and CEO of Blackwater, occurred before Henry Waxman's oversight committee just days earlier. In that respect,

valley, led by Geoffrey Smith a Sierra Club leader. Tom Lamb went on the hike and said it was quite enjoyable.

At 2pm, we started our seminar series, and I gave a presentation on Blackwater and the Blackwater West project to a full-capacity crowd in the Pavillion Building of Potrero County Park. After that session, we had a very short presentation by Psephos concerning the vote-counting situation in the recall election of the Potrero Planning Group, followed by two breakout sessions, one on the impacts of wildlife in the area by Rene Owens and the other on Militarization of the Border by Enrique Morones of Border Angels.

During that day, I was called frequently by Tom Reopelle of KNX radio in LA, and we had Fox-6 News, the local Fox affiliate on site. The Fox-6 News crew did an extensive interview that afternoon.

That evening, we went over to the "Rally Site" on the property of Randall Parks, only about a half mile from the Blackwater West project site. Here the group gathered for music and poetry. If you don't already know, Steve Kowit, a Potrero resident who teaches English at

Southwestern College is quite an accomplished poet, and read two of his master-pieces that evening. Several bands and performers played, some really quite good.

Later, many of the activists returned to Potrero County Park to camp for the night. Getting together in such a social atmosphere helped those in attendance to get to know each other and have deeper discussions that are usually not possible during the fervor of the rally and march. Indeed, we had four photojournalism students who came down from the Brooks Institute in Ventura to document the event. Take a note for the future as this is a great way to get free photojournalists who have great cameras to document any event in the future.

Sunday Morning, Dave Wiley and Jim Brown, both of Veterans for Peace held a well-attended session on war profiteering. That was good news as they moved their session from the slot opposite my Blackwater presentation.

Sunday was the big day. About 250 people gathered at the Rally Site and the rally itself started at 1pm. Our keynote speaker, Rep. Bob Filner spoke about being "Blackmailed" in a bad game of "Blackjack" by "Blackwater." He has proposed legislation that will make mercenary training on private property illegal. (However, his legislation does not go far enough and even seems to make mercenary training on government property sound just fine.) Also, speaking was Rick Jacobs of the Courage Campaign and Executive Producer of Iraq for Sale. We

attempted to arrange for Jeremy Scahill to come to the event but he was simply not able to get away from the peak of attention in DC, as you can imagine.

An incredible gaggle of media was present, from CNN to NPR to City Beat.

After the rally, the truck used for the stage headed up the march, about a half mile to the project site. I counted almost exactly 200 people taking part in the walk. About 2/3 of the way to the gate, two white jeeps driven by Blackwater employees passed the group with one of them

Blackwater employees passed the group, with one of them pointing his hand like a gun "shooting" at the protesters, and documented in a number of photos took by the crowd. I've been told that such a gesture amounts to assault--a threat--especially when you consider the trigger-happy mentality of Blackwater mercenaries. Indeed, if nothing else, it points out that these guys have a very limited repertoire of interactions with the world, with shooting being the singular behavior to apparently everything.

The 200-person platoon of protestors continued to march down the road, a majority wearing bright-green T-shirts emblazoned with Stop Blackwater, chanting "Stop Black Water." About 100 yards from the intended destination of the main gate to the property, a white Hummer sat to the side, and Brian Bonfiglio, VP Blackwater, stood next to a chain stretched across the road. Signs were displayed stating that no one would be allowed on the property.

The crowd bunched up at the unexpected chain and I worked my way to the front, putting my face in Bonfiglio's, demanding

> that they let us walk to the gate where we could see into the property. "Stop Black Water," the group continued chant. I can say that under the calm exterior of Bonfiglio, the power of 200 protesters in his face was quite unnerving, to be sure. As expected, Blackwater did not give in and become a cooperative and friendly neighbor, with apple pies and treats for the group. No, the best we got from this group was a hand formed into a gun and

repeatedly pointed and "shot" at the group. Not the kind of neighbor I'd want either.

Well, despite Bonfiglio's pathetic resistance with the chain across the road, the protesters simply turned

around and walked up a road to a power pole, providing a convenient overlook to the valley. The group took pictures and left a sign on the power pole as a reminder of the event.

On our return trip, we noted the 15 or so Pro-Blackwater protesters across the street from the Rally Site with a lackluster reaction to our grassroots rally. Instead of handpainted signs stating "Stop Blackwater," "Blackwater Go Home," "Stop War Profiteers," and the like, they had professionally made banners saying "Wait for the conclusions of the EIR" or "We support law enforcement and military training." Our rally organizers were smart to put out about ten American flags flying by the road so no one could make the claim that we are anti-American. Good Job.

At the rally, I met Ken King a selfdescribed "Conservative Republican" who is running for Duncan Hunter's seat. I called him after the rally and asked him why he was there. He said he supported our efforts from a property-rights standpoint, and supported the efforts of the Potrero residents to keep the outsider from setting up shop, a facility very inconsistent with the plan for the area. He said he knows Dianne Jacob pretty well and thinks that the project will never be approved. I'm not so sure, but I think we have a very good shot, especially if we can bring such people into our resistance effort.

On December 11, a recall election will be held for the Potrero Planning Group members who voted to support the project. In essence, this has become a referendum on the project. If the local voters decide against the project, then we will make it clear that it will be appropriate for Blackwater to pull out, and spare the community further agony fighting them. From their attitude at the gate, I doubt they will, but I'm willing to be surprised.

Our October 21st meeting was entitled the "Candidate Recruitfest" a new approach to finding viable candidates for the upcoming election year. If you've every even thought of providing your services to your community, there is probably a seat for you.

It turns out that in this are, many of the seats never even appear on the ballot, since they appoint a new replacement prior the election, and no one runs against the (typically) Republican crony incumbent.

Seats range from city commission positions, which are appointed by the mayor (and therefore hard to get for our progressive comrades) but if we get three or more to apply and no one else does, the City Council will have to appoint someone from that group.

Other seats, such as Community Planning Groups, School Boards, Water Boards, and Hospital Districts are elected but are not well compensated, if at all. City Councils, County Board of Supervisors, County Board of Education and other seats are sometimes very well compensated.

We have several fine candidates running in the $52^{\rm nd}$ congressional district, including newcomers Michael Lumpkin and Jim Hester.

Dianne Jacob will have to run a campaign this year, with two candidates

COPs "Arrest" Bob McClellan

El Cajon City Councilmember Bob McClellan started a new practice last month, "Constitutional Moments" based on a request by Mayor Mark Lewis. Incorporated as part of the official agenda of city business, it was simply an excuse for McClellan to promote his religious beliefs, including the concept that our founding fathers intended for this to be a Christian nation, and that the notion of Church and State separation is a myth. This is a similar tactic used when McClellan had videos produced by David Barton (Ex vice chair of the Republican Party of Texas and Tom Delay associate) to promote partisan-Republican and Church/State commingling played on the Government Access channel (Cox-24) for four years. Indeed, this was the reason we started COPs, so we could nip this sort of activity in the bud.

COPs sent in a formal request to the City that this practice be stopped. However, we support the notion that McClellan can speak during the Public Comment portion of the meeting, as long as he makes his comments from the public microphone and not from his seat as councilmember. The City Attorney sent the council a private letter stating that the practice must stop or they would face a lawsuit (which I threatened in my letter.) At the Oct. 9th meeting, the item was no longer on the agenda, but McClellan proceeded to make his "public comment" from the dais. It looks like another letter is in order.

We appreciate the several people who came to the city council meeting to speak against this behavior, especially since the City Council has more important things to do as they are \$3.8 million in the red and have a possible police strike staring them in the face. Indeed, the actions of McClellan are not much more than a media-diversion tactic, and it worked. The UT presented his picture

several times, but has only light coverage of the red ink.

Kudos to the City Attorney, Morgan Foley, for doing the right thing and standing up to this extreme behavior by the City Council. Indeed, this is a way for the evang-unethicals in the area to promote the concept that God is being kicked out of government, pandering to those who want more integration of Christian dogma. Our best bet is probably to ignore the whole thing once we put a stop to it. I can only wonder if this means that McClellan will run again or not.

All I can say is that the COPs are having their intended effect. The City Council would have no one there to limit their excesses if we weren't there.

Find a governmental body to oversee. this is a very powerful way to get our country back, to draw the line in the sand of propriety.
