Potrero Planning Group Gets New Blood, Slow Start

Effort to revisit Blackwater issue tabled due to processing details.

We know what the Potrero Community Planning Group (PCPG) wants to do. The five former pro-Blackwater members were all removed with an unprecedented landslide recall. The new group simply wants to revisit the earlier approval of the Blackwater West project and vote it down. It sounds easy, but with Blackwater and the disgruntled pro-Blackwater members now in the audience and watching for any

chance to trip up their rivals, it's not a slam-dunk.

At the January 10, 2008 meeting in Potrero, the new members took their seats behind a newly prepared agenda with the intention to reconsider the earlier approval of Form 534, the form used to transmit actions from planning groups to the DPLU. The earlier vote was taken in December, 2006, after a single meeting reviewing the huge project before only a dozen residents.

Unfortunately, the idea of "reconsidering" the earlier approval was scuttled after a comment by Jerry VanDeweghe (pronounced "Van-De-Way") the assistant to Senator Hollingsworth (R-CA-36), who said it was not possible for the group to make a motion to reconsider. Indeed *Robert's Rules of Order* states that a motion to reconsider can only be brought to the floor by a member who

ENDORSEMENTS!

The ECDC has important endorsement events coming up.

State Endorsements: Rechartering the club is our first step. Then, we must submit all of our members that are in any single Assembly District to the State director for Region 21 (Steve Rivera). We get one endorsement vote for every 20 members who reside in a single AD. At the time of this writing, we have 141 members with 112 members in the 77th AD. That means we get five endorsement votes. (Please send in your membership ASAP and we may be able to get one more vote!)

This endorsement is for candidates at the June primary and can be very important. The state party endorsement can be very important in that primary!

Secondly, we have votes in the California Democratic Council, which is the statewide body of clubs.

Club endorsements will be voted on after the deadline for applications (early March) and after the candidates have had a chance to complete our questionnaire, most likely at the April meeting. Please note: your membership must be current for 30 days to vote at these important endorsement meetings!

was on the prevailing side of the earlier vote. Since no one is left on the panel who voted for the earlier approval, that makes that action impossible.

The group should have used a motion to amend after adoption, sometimes called rescind, repeal or annul. So, this key issue on Blackwater could not be processed as desired. Yet, it will be a simple matter to get the agenda corrected for the next meeting. Pro-Blackwater activists have only delayed the inevitable for one meeting.

That wasn't the only important item on the agenda, however. Officers were selected, with Carl Meyer taking the role as the Chair and Terry Stephens as Vice Chair. Since Janet Goode was not present, Terry Stephens also took the role of Secretary Pro Tem. With this new leadership, we will likely see a meeting under a tighter hand and new, fairer procedures.

Another even more difficult issue was filling three vacancies that exist in the

group. This will take a bit more explanation as it is about as clear as mud.

The PCPG is designated by the County to have nine members. Just prior to the service of recall notices, Emil Susu was found not to be registered to vote in the county, and so he was removed. Then it was discovered that two other members were never properly approved by the County Board of Supervisors.

According to the policy that governs the Planning Groups—Policy I-1—they are allowed to consider appointing the unsuccessful candidates in the prior normally scheduled election for any vacancies. You can bet that the three pro-Blackwater candidates from the recall expected to walk in and land in those vacant seats.

However, only one person fell within the strict reading of the requirements, pro-Blackwater Edward Boryla, who ran against William Crawley IV, and received only about 22% of the vote. After a short speech and some support from the ousted members, the new panel considered his appointment but he received no support. The body wished to open the vacancies up to anyone in the community who would wish to submit an application, and they would conduct interviews at a future meeting. Indeed, this step seems prudent.

They did the right thing, but it was not at all easy. Even videotaping the meeting required some backbone to relentless attempts to intimidate by some residents who said I had no right to be there with my camera. "Who do you represent?" asked Emil Susu, as he attempted to take a poll in the room and apparently try to get me kicked out It might even be necessary to call for Sheriffs Dept. protection in future meetings to avoid and document verbal threats.

The next PCPG meeting is on Feb. 14th. You can bet that few, if any, valentines will be traded in the meeting, if the tension continues as it has been in the past.

Parkway Mall Allows ECDC Voter Registration Table

Parkway Plaza said we couldn't register voters in their "private" mall. But after I sent a couple of stern faxes, they relented to the stark reality that the Supreme Court has held that such access must be allowed. The famous "Pruneyard" case was used as the key to unlock their door of resistance, along with the more recent case involving Fashion Valley Center and the union representing workers at the Union Tribune. In that latter case, newspaper workers were picketing one of the stores in Fashion Valley during a strike of the newspaper workers. The court held that picketing and boycotts of the stores must be allowed as these malls have become replacements for the town square.



The mall supplies a table, skirting, and up to three chairs. They gave us our last choice of three location options, but it turns out that the hallway just outside WalMart has actually been very productive. Once they gave in, the mall has been easy to work with. We did have to wait until after the holiday shopping season, as that was blacked-out, as may be expected.

The production at the mall has been amazing. Over the six days, we registered about 250 voters, with about 80% or more registering as Democrats. We still have three more days, and may exceed 300 registrations.

We must give Kristy Mundt a round of applause for coordinating the volunteers and a warm "thank you" to all the volunteers who rose to the occasion. Now that we know to do this, we can easily schedule a table at the mall perhaps a weekend once a month. This is certainly one of the best ways to turn this East County from red to blue in short order. If you didn't get a chance to volunteer, keep your ears open for future registration events. It's a great way to invest just a few short hours with maximal benefit!

El Cajon City holds red-ink emergency meeting

It's official. El Cajon is being run by a bunch of goons. After reporting a budget deficit of at least \$3.8 million in the budget of July 1, 2007, the city has scheduled an emergency meeting on January 22nd in the 5th floor meeting room at 1:30pm. It turns out that the number is more like \$4.2 million when recent \$1K payouts to all employees and benefit increases are factored in, and then a sales tax shortfall makes it more like \$6.2 million. Ouch.

At the same time, they have to try to explain spending over \$3 million to beautify Main Street, and continuing to subsidize CCT (Christian Community Theater) in their takeover of ECPAC.

If their plan is to avoid prying eyes of the video cameras present in the City Council chambers, it's not going to work. COPs will be there with our own camera, and we'll post the dirty little secret to Google video so all the world can see the mess they're in.

Meanwhile, the City Council works on dog walking restrictions, outside smoking restrictions, RV restrictions, and head shop restrictions. Then, they give constitutional history lessons from the dais as they say prayers (It's too bad those prayers don't seem to do any good, do they!) They abolish the traffic commission, allegedly to save money by limiting the support of that volunteer body. Instead, they want to handle traffic complaints during Council sessions. It seems anything is better to talk about than one thing: the budget.

Will the evang-unethical churches they are appealing to with these antics find some \$6.2 million dollars in their donation basket to balance the budget? How about Daryl Priest, who walked away with the city property at Ballantyne and Park worth millions, while paying only a pittance?

In a recent meeting, the union representing Police Officers said that El

Cajon is underpaying their officers to the point where many are moving to other cities where compensation is competitive. Who would start a career here, when the City ignores its financial red ink and pleas for expected raises?

He didn't mention that poor El Cajon residents are already the most heavily sales-taxed in the county. Why go to the Parkway Mall with higher taxes when you can go over to Grossmont Center and avoid the extra surcharge?

Sure, there's been a drop in sales tax revenue. Bush wants to continue the myth that all is well. "Don't worry about a thing, just go shopping." But at the same time, worry your little head off about the evil terrorists who may attack at any moment. Sorry, their false economy is finally starting to show its ugly Republican face.
