 - 2. Quote: "These communications informed FDA of the steps taken by Monsanto to ensure that these products comply with the legal and regulatory requirements that fall within FDA's jurisdiction."
 - --> Please include records defining the "steps taken by Monsanto."
 - 3. Quote: "Based on the safety and nutritional assessments you have conducted, it is our understanding that Monsanto has concluded that corn grain (kernels), fodder and silage derived from the new varieties are not materially different in composition, safety, and other relevant parameters from corn grain (kernels), fodder and silage currently on the market, and that the genetically modified corn does not raise issues that would require premarket review or approval by FDA."
 - --> Please provide the safety and nutritional assessments conducted by Monsanto, in either exhaustive or summary form, as reviewed by FDA staff to reach its "understanding."

 - --> Please provide documents that define "safe" and "wholesome"
 - --> Please provide documents that define "all applicable legal and regulatory requirements" which are maintained by your agency related to such genetically engineered food such as MON802
- 3. Please provide meeting notes and any other records related to any other meetings on BNF0035 other than the March 10, 1995 meeting, as mentioned above.
