Report of 1 Percent Manual Tally of Random Precincts And 100 Percent Manual Tally of Votes Cast on Touch Screens For the June 5, 2012 Consolidated Presidential Primary Election

Per California Elections Code § 15360, 1% of randomly selected precincts and 1% of vote by mail ballots cast in the election selected at random by batch are to be hand tallied to verify the accuracy of the voting system tabulation. Conditional re-approval by the Secretary of State of the county's accessible touch screen voting units requires a 100% manual tally of all votes on the units.

The public was noticed the random selection of precincts and batches would occur on June 11, 2012 at 9 a.m. and the manual tally of the ballots would commence following the random selection. The random selection was accomplished by blindly drawing strips of paper with precinct and batch numbers printed on them. The tally began on June 11, 2012 and was completed on June 12, 2012.

With 68 polling place precincts and 39,013 vote by mail ballots, El Dorado County would need to randomly select 1 precinct and sufficient batches to total at least 391 ballots. Historically, El Dorado County draws additional random precincts for each of the county's five supervisorial districts, exceeding the legal requirement. An additional precinct was drawn to include the Pollock Pines Elementary School District Bond Measure. All races and measures were tallied for each precinct and batch selected for the manual tally.

It was determined that a voter marked a continuous vertical line through all ovals for all candidates in this contest. The optical scanner read it as a blank ballot. The results were corrected to reflect the manual tally board's reading. (2) Manual tally board counted one less vote for a candidate and one more over vote in the Superior Court Judge contest. It was determined that a voter marked a continuous vertical line through all ovals for all candidates in this contest. The optical scanner read it as a vote for one candidate. The results were corrected to reflect the manual tally board's reading.

400006.06 - Balanced on first pass

500007.10 – Manual tally board counted one less blank and one more vote. It was determined that a voter did not properly fill in the oval, but the selection was obvious to human eye. The results were corrected to reflect the manual tally board's reading.

500021.09 – (1) Manual tally board read one less blank and one more vote in the Democratic Presidential contest. It was determined that a voter did not properly fill in the oval, but the selection was obvious to human eye. The results were corrected to reflect the manual tally board's reading.
