SUBJECT: Your Public Records Act Request, dated July 8, 2016

Dear Mr. Lutz:

The County Clerk/Registrar of Voters/Elections Official for the County of Fresno received the above-referenced Public records Act request, addressed to the elections official-County of Fresno and sent to borth@co.fresno.ca.us on July 8, 2016. The request seeks reports for the 1% manual tally for the following elections: June 2016, November 2014, June 2014, November 2012, and June 2012. Further, you have requested the aforementioned reports be provided to you in electronic form and/or via a link to a web page.

On July 18, 2016, the County provided its initial response to your request by sending you the **1% Manual Tally report for the June 2016 election** (in electronic form) along with a Letter explaining that due to the difficulty in searching/viewing stored files and your request coming at the time of year when many of the Elections Official's office staff are fully occupied in preparations for the general election in November 2016, the County had determined that unusual circumstances existed which necessitated the extension of the County's time to respond to your records request by an additional 14 days: To the date of August 1, 2016. (Government Code section 6253, subdivision (c)(1)-(2).)
